ORDINANCE NO. 16-21

AN ORDINANCE AMENDING THE VILLAGE CODE TO INCREASE THE SALARIES OF VILLAGE TRUSTEES

WHEREAS, the Village of Rochester (“Village”) is a municipality located in Sangamon County, Illinois; and,

WHEREAS, the salaries for elected officials in the Village have not been increased since 2002, with the increase taking effect May 1, 2003; and,

WHEREAS, similarly situated municipalities have been surveyed regarding the compensation paid to elected officials; and,

WHEREAS, section 65 ILCS 5/3.1-50-10 of the State of Illinois Municipal Code provides that the corporate authorities of a municipality may fix the salaries of all municipal officers at least 180 days before the beginning of the terms of the officers whose compensation is to be fixed; and,

WHEREAS, the corporate authorities of the Village believe it to be in the best interest of the Village to increase the salaries of Village Trustees.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Rochester, Illinois, as follows:

Section 1. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Amendment to Village Code. The Village Code shall be and is hereby amended as follows:

1-3-1 SALARIES OF VILLAGE OFFICIALS. The following salaries are hereby established for elected Village Officials:

(B) **Trustees.** The Village Trustees shall receive Two Thousand Six Hundred

(\$2,600.00) per year. In addition, Village Trustees shall be entitled to a stipend of Thirty Dollars (\$30.00) per Village Committee Meeting attended if the Village Trustee is a member of said Village Committee or per other meeting attended if ordered to attend by the Village President. Village Trustees may earn up to a maximum total yearly stipend amount of One Thousand Two Hundred Dollars (\$1,200.00).

Section 3. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Rochester prior to the effective date of this ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law. The new salary shall begin after the 2017 terms of the officials begin.
