**AN ORDINANCE INCREASING THE STIPEND FOR THE VILLAGE
DEPUTY CLERK**

WHEREAS, the Village of Rochester (“Village”) is a municipality located in Sangamon County, Illinois; and,

WHEREAS, pursuant to 65 ILCS 5/3.1-30-10, the municipal clerk, when authorized by the corporate authority, may appoint deputy clerks; and,

WHEREAS, the Village has paid and continues to pay the deputy clerk a stipend for clerking Village and committee meetings; and,

WHEREAS, similarly situated municipalities have been surveyed regarding the compensation paid to deputy village clerks for clerking village and committee meetings; and,

WHEREAS, corporate authorities of the Village believe it to be in the best interest of the Village to increase the stipend paid to the Village Deputy Clerk.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Rochester, Illinois, as follows:

Section 1. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Deputy Clerk Stipend. Beginning May 1, 2017, the Deputy Clerk shall be paid Thirty Dollars (\$30.00) per Village or committee meeting clerked.

Section 3. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 4. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict


herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Rochester prior to the effective date of this ordinance.


Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law. The new stipend shall begin after on May 1, 2017.
