**ORDINANCE NO. 19-13**

**AN ORDINANCE APPROVING THE SUPPLEMENTAL TEMPORARY  
CONSTRUCTION EASEMENT**

**WHEREAS**, the Village of Rochester (“Village”) is a municipality located in Sangamon County, Illinois; and,

**WHEREAS**, on November 13, 2017, the Village passed Ordinance 17-35 approving Permanent Easements with a Temporary Construction Easement; and,

**WHEREAS**, the Temporary Construction Easement approved by Ordinance 17-35 and Recorded as Exhibit A in document 2018R02464 filed with the Sangamon County Recorder’s Office expired on December 18, 2018; and,

**WHEREAS**, the Village desires to complete the construction of said easements in compliance with the provisions of document 2018R02464; and,

**WHEREAS**, the Diocese and Village desire to enter into a Supplemental Temporary Construction Easement that allows extends the Temporary Construction Easement to September 1, 2019.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Rochester, County of Sangamon, as follows:

**Section 1.** Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Resolution as if fully set forth in this Section 1.

**Section 2.** Approval of Easement. The Board of Trustees of the Village hereby approved the Supplemental Temporary Construction Easement as attached as **Exhibit 1** by and between the Village and the Roman Catholic Diocese of Springfield in Illinois Trustee Corporation, Trustee of St. Jude Parish of Rochester, Sangamon County, Illinois, Real Estate Trust.

**Section 3. Authorization.** The Village President is hereby authorized to enter into the Supplemental Temporary Construction Easement attached hereto and take any such other and further acts necessary to complete the procurement of the easements contemplated by this Ordinance.

**Section 4. Severability.** In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

**Section 5. Repeal and Savings Clause.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Rochester prior to the effective date of this ordinance.

**Section 6. Effective Date.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
