**ORDINANCE NO 19 - 25**

**AN ORDINANCE ABATING THE 2019 TAX LEVY FOR PAYMENT OF  
THE VILLAGE OF ROCHESTER, SANGAMON COUNTY, ILLINOIS,  
GENERAL OBLIGATION BONDS (ALTERNATE REVENUE SOURCE),  
SERIES 2013**

**WHEREAS**, the Village of Rochester ("Village") is an Illinois Municipal Corporation existing and operating under the Illinois Municipal Code and the laws of the State of Illinois; and

**WHEREAS**, the Village of Rochester, Illinois (the "Village") has issued its General Obligation Bonds (Alternate Revenue Source), Series 2013 (the "Bonds") pursuant to Ordinance adopted September 16, 2013 (the "Bond Ordinance"); and

**WHEREAS**, Section 15 of the Bond Ordinance provides for an annual tax levy to pay principal and interest on the Bonds, and further provides that the Village may abate the tax levy if the Board of Trustees of the Village (the "Board") determines the Village has funds sufficient to support the payments due upon the Bonds; and

**WHEREAS**, pursuant to the Bond Ordinance, the Village established a separate fund which the Board does hereby determine contains sufficient funds to pay the principal at maturity of and interest on the Bonds, next coming due without extending the tax levy; and

**WHEREAS**, the Board does further determine that it is advisable, necessary and in the best interests of the public health, safety and welfare to make proper abatements of the taxes levied pursuant to Section 15 of the Bond Ordinance for the year 2019 and to be extended in the year 2020 (the "Tax Levy").

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Rochester, Sangamon County, Illinois, as follows:

**Section 1. Recitals.** The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**Section 2. Determination to Abate Tax Levy.** The Board does hereby determine to abate the Tax Levy set forth in Ordinance 13-14 for the Bonds and authorizes the officers of the Village to file such documents and make such certifications to the County Clerk of Sangamon County, Illinois, as may be necessary to direct the County Clerk to abate the Tax Levy and forego extension of the Tax Levy.

**Section 3. Repeal and Savings Clause.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Rochester prior to the effective date of this ordinance.


**Section 4. Effectiveness.** This ordinance shall be in full force and effect from and after passage, approval and publication in pamphlet form as provided by law.
