**ORDINANCE NO. 20-05**

**AN ORDINANCE WAIVING THE PARK REGULATIONS TO ALLOW ALCOHOLIC BEVERAGES AT COMMUNITY PARK ON JUNE 20, 2020 FOR SPARKS IN THE PARK**

**WHEREAS**, the Village of Rochester (hereinafter “Village”), Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and,

**WHEREAS**, the Chapter 28 of the Village Code regulates the use of the Village Parks; and,

**WHEREAS**, Section 28-1-26 of the Village Code states it shall be unlawful for any person to sell alcoholic beverages in the park; and,

**WHEREAS**, Section 21-3-11 of the Village Liquor Code makes it unlawful to drink any alcoholic liquor in any public park, except in compliance with all applicable Village ordinances, rules, and regulations; and,

**WHEREAS**, the Village is holding its annual Sparks in the Park event on June 20, 2020; and,

**WHEREAS**, at Sparks in the Park, it is requested that alcohol be served and therefore a waiver is necessary to allow alcohol at the event; and

**WHEREAS**, the Corporate Authorities of the Village believe it is in the best interest of the Village to allow alcoholic beverages at the park as part of Sparks in the Park on June 20, 2020, in accordance with the regulations set forth in this Ordinance.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Rochester, County of Sangamon, that the provisions prohibiting sale and

consumption alcoholic beverages at Rochester Community Park be waived on June 20, 2020, from 1:00 p.m. until 12:00 a.m. on Sunday, June 21, for Sparks in the Park. This Ordinance in no way waives the prohibitions on public intoxication found in Sections 21-3-11(D) and Section 28-1-26 of the Village Code. Nothing herein shall waive the licensing requirements in Chapter 21 Article II of the Village Code. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
