ORDINANCE NO. 20-14

**AN ORDINANCE PROVIDING FOR THE LOCATION OF ADDITIONAL STOP SIGNS
IN THE VILLAGE OF ROCHESTER**

WHEREAS, the Village of Rochester, Sangamon County, State of Illinois, is a duly organized and existing Village created under the provisions of the laws of the State of Illinois; and,

WHEREAS, the Village of Rochester is authorized by the Illinois Vehicle Code, 625 ILCS 5/11-208, to regulate traffic by means of traffic control signs; and

WHEREAS, Chapter 23 Article III of the Village Code provides the Village Board of Trustees may designate certain streets as stop streets and that said signs shall be posted at the appropriate locations indicating said stop streets; and

WHEREAS, the Village currently has stop signs not reflected in its Code at the following locations:

Through Street	Stop Street (Direction)
East Main Street	North Walnut Street (southbound)
East Main Street	Cardinal Hill Road (northbound)
East Main Street	Cardinal Hill Road (southbound)
East Main Street	Maple Street (southbound)
West Main Street	Twin Oaks (northbound)
West Main Street	Wildrose (northbound)
West Main Street	Deer Creek (northbound)
West Main Street	Bertrand Drive (southbound)
Illinois Route 29	Taft Drive (southbound)
Illinois Route 29	Camelot (southbound)
Illinois Route 29	Rocket Drive (southbound)
Cardinal Hill	Jack Taylor (westbound)
Waterwheel	Magnolia (westbound)
North Walnut Street	Rochester High School Parking Lot (north lot)
North Walnut Street	Rochester High School Parking Lot (south lot)

WHEREAS, the Village Police Chief and Village Engineer have recommended that stop signs be added at the following intersections:

Through Street	Stop Street (Direction)
Old Timbers	Waterwheel (northbound)
Old Timbers	Waterwheel (southbound)
Old Timbers	Sawmill (northbound)
Old Timbers	Sawmill (southbound)
Old Timbers	Parkview Drive (northbound)
Guinevere Drive	Lancelot Drive (westbound)
Guinevere Drive	Arthur Drive (southbound)

WHEREAS, the placement of the above-referenced stop signs is in keeping with standard engineering practices, will help regulate the flow of traffic and ultimately increase safety for the residents; and,

WHEREAS, the Village Board of Trustees and the President of the Village of Rochester believe it is in the best interests of the Village to amend its Code and add additional stop signs as provided for below.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Rochester, County of Sangamon, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Amendment to Traffic Signals. The Village Code shall be amended by adding the following stop signals:

Section 3. Authorization. The Village President or his designee is hereby authorized to include the above referenced through and stop streets in the upcoming recodification on the Village Code in a manner and location within the Code that is appropriate. The Village Public Works Department is hereby authorized to add new stop signs at the new locations designated herein.

Section 4. Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this ordinance and the application thereof to the greatest extent permitted by law.

Section 5. Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to the Village of Rochester prior to the effective date of this ordinance.

Section 6. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
