President Suerdieck announced that due to increases in water rates through the Sangamon County Water Reclamation we may need to increase our sewer rates 4-5%. He mentioned we were working on it and the final calculations.

**Water/Sewer**

Spectra Tech put a bid in to seal the North lift station and it came in high at 60k, with the extra pumps that will be needed to complete the job we are looking at 70k.

Upon staking the easements for the North Oak Hill Sewer Extension Project some of the residents are concerned of the exact path.

The 10X10 Project has found a high pressured gas main directly in the path of where the work needs done. Project has been put on hold until we consider all options.

Grove Park will be surveying yards and will be putting flyers on the doors of residence or going door to door to notify residence.

Generator is still not installed yet. It has a slightly bigger footprint than the previous generator so we will need to figure out how to make it work with the concrete pad we have or make it bigger.

Merry go round at the park is broke and it is closed due to it being a safety concern. Some wood slats are also broken and need repair.

Removed the dead tree in front of Village Hall. Need to decide what we want to replace it with. Dan Wallace, the owner of Rochester Station is asking to put a concrete sidewalk and pad for sitting from the bike path to the Lighthouse restaurant at no charge to the village. The bike rack we currently have was rotted out and removed recently. We need a new bike rack something surface mounted rather than in the concrete. As the Village we will look in to buying a new bike rack. All in favor for moving forward with this.

Owner of Lighthouse would like to put the large lighthouse back on the village property. May need to go to P& Z for approval. With the new sign it may be too much.

Water connection fees are changing for new homes. It is now 1365.00 This is to help with fees. RYAA purchased equipment to make Ramsey field wireless. Equipment was sent to us. We fixed the batting cage also.

### **Police Chief Report-Chief Sommer**

We have hired a new part time officer named Travis Campbell. He is good to go with training. Rita Nichol is a corrections officer at Sangamon County and a control tactics instructor. She will start the academy May fourth at Illinois Southwestern College.

Detective Harris completed his 80hr. course for detective training up by Chicago. We have been buying our own stuff to process crime scenes here in house. It was a re imbusement course. Officer Doolin and K9 Jett completed the recert training and was in the top half of class.

Would like to get a hiring list in place for future hires.

After the recent lost dog, we had so many people reach out wanting to foster so we are going to start a new program Founded Foster. Help foster dogs until we find an owner or get the application process started to adopt. This will allow us to avoid the pound.

Wild canine donated a chip reader so we can locate pet owners.

Compiling a list to use when we need extra help at events.
