#### **PUBLIC FORUM**

Wanda Ward was present and explained that 2-3 years ago, a group walked through Oak Hills on Maddox Circle. When it rains, water stands on part of the circle. She goes out and mows that section. Recently the road was patched by the mailboxes and now water sets around that and doesn't drain off. Can more asphalt be laid to help water drainage? Supt. Foster responded with there is no place for the water to flow away to. More asphalt could be added, but that pushes the water back into the yards. So in not addressing that, they are trying to limit intrusion on homeowners. It is the low point in that area, unfortunately. So without major revisions, nothing is really a viable option.

James Dubin — Thank you to the board for the support of Memorial Day Observation over the past couple of years. See handout — in the past, parking has been in the park, but this year, we would like parking to be closer to the cemetery. The pavilion will be needed. Trustee Munroe offered to reserve the pavilion with office. Signage will be necessary again this year, which they will work with Public Works and Police. Trustee Hendrickson commended Dubin for the great work he and the committee have done.

- A. Primary Lift System had a problem due to a spoon that made it through the system. The spoon was located and removed. This resolved the problem.
- B. New generator had an issue with mice chewing on the \$700 harness. More anti-mice systems have been put in place.
- C. The Village Park is open and water is on, the leak continues. The guy Supt. Foster talked to about finding the leak gave several suggestions so they will try that this week.
- D. The burn area is open for the season and several people have utilized it.
- E. 8 paint cans were left down by the burn area there is a fine for illegal dumping if the person can be located.
- F. Solar installations are happening in town. The process takes only one day to install. Trustee Hendrickson asked if there is oversight on structure and electrical needs. Supt. Foster explained that oversight is the responsibility of the owner and installer.
