- A. The water leak at Community Park has been chased to no avail. We are still losing water at 61 gallons/hour.
- B. Meters and transmitters that were ordered last year have arrived and those are getting installed. Over 1/3 of the way through with change outs.
- C. Supt. Foster explained that there is a berm in the Arboretum. Do we need to keep that berm or can it be leveled? Trustee Hendrickson said, it could be leveled with no problem.

- D. The shrubs by the Rochester sign on 29 coming in from Taylorville have been removed so the sign can be seen better. The sign will need some freshening work.
- E. Ditch behind Rocket Fitness The owner of the property is going to work on finding information about the ditch.
- F. Trustee Hendrickson reported that over 100 high school students helped plant 112 trees in the Community Park and Wanless Park this past week. Thanks to those students and Public Works for their help and to the 3 community members that led the task. These trees will go into the Carbon Credit line to help parks and trees. The total cost was about \$1600.
