#### **PUBLIC FORUM**

Trustee Hendrickson presented the Arboretum Committee Report – In May and June, more than 60 volunteers planted over 200 trees of 12 native Illinois species in three Village parks and the Village Hall grounds. There were five memorial tree planting ceremonies planned for families and the Sesquicentennial Committee. The Arboretum Committee and Village expresses thanks to all those involved. Most of the larger trees planted in North Park and Wanless Park have deer cages to protect from the high populations of deer in those areas. Residents living near the parks or visiting the parks are asked to report problems to the Village.

A draft policy statement on memorial trees was developed, revised, and forwarded to the Parks Committee for revision and adoption. It encourages the planting of memorial trees and sets standards for trees, locations, and plaques.

## **PUBLIC WORKS SUPERINTENDENT REPORT – James Foster**

# Water/Sewer

- Installed irrigation meter on Quail Crossing. JK Snyder hired to bore from tap point to pit location. Meter to be installed.
- Received complaints about sanitation sewers on Sattley and on Walberta. Sewers were jetted.
- No update on new sewer extension. Waiting to hear from engineer.
- New testing equipment for NAP ordered. They are experiencing a backlog due to this new requirement. Projected ship date is in August.
- New heater placed at Primary Lift Station.
- Transfer switch at SE Lift Station was not properly switching back to commercial AC from generator power after power loss. New transfer switch installed.
- Received 19 locate requests in one day. Normal is 4-5 per day.
- Storage facility has now tapped our water main.
- New home on Lot 58 Penacook had water line bored by JK Snyder. Water main has not been located yet. SubSurface Solutions is expected tomorrow to assist with troubleshooting difficult to locate lines.
- PW is planning on water main flushing from July 1<sup>st</sup> to September 30<sup>th</sup>.

# **Streets**

- Work continues on Mill and Pleasant. Utilities must be carefully exposed for project. We are also deeper than expected to have to be to maintain proper fall to get water to flow towards creek.
- A sinkhole has appeared at the North Walnut Street Apartments near their dumpster. A steel plate has been placed over hole until repaired.
- Mailbox on Burberry possibly hit by snowplows has finally been replaced.
- Driveway culvert on Parkview jetted for homeowner who replaced drive.
- Pothole filling was done.
- Point repairs have been rescheduled for the cooler months and due to Mill/Pleasant Project taking longer than hoped.

# Parks/Property

- Lots of new trees planted all over the village properties.
- Stone House continues to be mowed and maintained.
- Assisted library with clean up of Racheal's Garden.
- Comfort Station door handle broke and has been repaired.
- Tables at the large pavilion have been chained together to prevent vandals from stacking them.
- Feces found covering Comfort Station walls and floor.
- Clearing of land at Wanless Park wrapping up.

- Henton and Foster attended a Maguire Iron webinar on "System Coatings".
- Most of the Public Works attended a Sangamon County DPH webinar for mosquito control.

# **Code Officer Info**

- Received a few complaints about tall grass throughout the Village. Letters were sent and individuals are now in compliance.
- Received a complaint about barking dogs and smell of feces. Officer Henton and I investigated and found nothing to substantiate this complaint. Spoke with dog owner and advised continued maintenance.
