Bill Rodgers – Pub House is closed. The new tenant is supposed to be open by December 1st. He believes the previous water bill is still outstanding. The new tenant is to be Nesty's, from Taylorville, and will have a second location in Rochester. They have a variety of food on their menu. Mr. Rodgers asked what the process is to get a liquor license? It can be fairly lengthy. They can apply at the Village Hall. Is having the license in place by December 1 a possibility? Yes, likely.
