- A. Officer Shelton will start the Academy in January.
- B. Chief would like to move ahead with the next person on his list, to be prepared for when Officer Meadows job offer from the State Police is made.
- C. It was a good year for the ELVES program.
- D. Trustee Hendrickson asked if it was true that all of the vehicles that were stolen were unlocked and 1 had the key in it as well? Chief Sommer confirmed that to be accurate information.

Public Works Superintendent – James Foster

See attached report – highlights below.

- A. Lift stations are having some issues. A new pump may be needed soon.
- B. Street Department borrowed the school district's line painter. They are trying it out in a few areas to see how it works, and they want to get more lines painted.
- C. There is a house on Mishawaka that has a concrete structure in the yard that may be connected to the water/sewer system. It was not designed by the homeowner as originally thought.
- D. More tree trimming has been done at the park.
- E. Supt. Foster and President Suerdieck met with EcoSilt, a local business, about the pond reestablishment. They provided different options than the St. Louis company did.

- F. The 4th of the CDL students have taken and passed his test. More staff will be trained in the spring. Southern View has reached out to Supt. Foster about doing training for their staff. Foster's answer to them was that it is a decision that needs to be made between the boards. His thought is to have at least compensation for his time OR can there be some sort of time or effort traded for the training. His amount of time spent will depend on the skill set of the student(s).
- G. The Scooter, the little red unit, is having some major parts issues. She may be included in the budget either later this year or next year. Supt. Foster is looking at a Kubota side-by-side. Brand new is only \$25,000.
- H. Supt. Foster has had repeated complaints on Park View. Neighbors have all reached out with concerns. However, as one issue gets resolved another issue comes up.

NEW BUSINESS:

RES 24-26 – Approving The Blue Cross Blue Shield Policy G532bce Blue Choice Preferred for Term Beginning 01/01/2025 and Ending 12/31/2025. This is like past policies. However, all the prices have gone up like all insurances and benefits have gone down. With all of that, it is still the best choice provided. Two other companies were checked as well with significantly higher prices, but the benefits stayed where they are. No change of doctors or providers would be required. There were 8-10 other choices from BCBS, with significant changes to everything. So, Pres. Suerdieck and Office Manager Marsh suggest staying where the Village is currently. Trustee Hendrickson asked if this would affect contracts with Union 965 and Police Union? Pres. Suerdieck answered that it won't impact either of those as it is very similar to what they already have.
