- 1 A copy of the signed contract between the homeowner and the solar company.
- 2 Required information on a site plan per Ordinance includes; property owner name, address, phone number. Also required are all property lines, all structures on property, any septic fields, setback lines, location of all solar panels and associated equipment, location of electrical disconnect for solar energy system.
- 3 Also Required is Evidence that the local electric utility has been informed of the customer's intent to install a customer-owned energy system.
- 4 A site plan must also be submitted to the local fire protection district at john.archer@rochesterfirerescue.org.
- 5 Proper warning signage has been located to inform utilities of renewable energy that are present on site.
- 6 A representative of the company must be present at inspection.
- 7 Once approved, the homeowner may pick up building placard for display at property until inspections are complete and passed.
