## VENDORS AGREEMENT

Sparks in the Park Committee

And

Upon payment and acceptance of signed vendor's agreement, the Sparks in the Park Committee (SPC) shall:

- 1. Provide the vendor with one parking space.
- 2. Assume no liability for loss or damage of goods and property of vendor.
- 3. THESE ITEMS MAY NOT BE SOLD BY ANY VENDOR:
  Cotton Candy, Sno-Cones, Popcorn, Funnel Cakes or Elephant Ears
  -violation of these terms will result in removal from the event with
  no refund

## PRIVILEGE RESTRICTIONS:

- Signed and dated vendors agreements with pertinent information and a fee of \$35.00 and Food Trucks with a fee of \$75.00 returned by Friday, June 11, 2021. Agreements received after that date will not be accepted. All fees are payable to the Village of Rochester.
- Agreements may be returned to the Village office, Attention: SPC, #1 Community Drive, Rochester, II 62563. Agreements must be signed by a member of the SPC to be considered valid. If you have questions or need additional information send an email to sparks@rochester.illinois.gov or call the Village office at 498-7192.
- The vendor will use the vendor's space and no part of the assigned space will be sublet, loaned or otherwise used by anyone other than the vendor without prior approval by SPC.
- 4. Vendors selling merchandise shall be permitted to sell and distribute merchandise only from the booth assigned them. Food will not be permitted to be sold without prior approval of SPC and the proper Sangamon County Health permits.
- 5. SPC is solely responsible for determining the types of merchandise for sale and the number and types of vendors.

## **VENDORS SHALL:**

- 1. Agree to procure all necessary licenses, permits, signs, decorations, tables, chairs, fixtures, lighting, booth and/or tent for their exhibit.
- 2. Agree to pay all city, state, and county sales tax and health permit fees where appropriate.
- 3. Agree to obey all applicable Federal, State, County, and Local Health Sanitation regulations, electrical code and fire ordinances.
- 4. Agree to maintain a neat and presentable exhibit, free of litter and waste material and to leave the vendors space clean and free of litter upon conclusion of this event.
- 5. Agree that all vehicles will be removed from the vending area and parked in the designated parking area for the entire event.
- 6. Agree to remove merchandise or cease operations as determined by SPC officials if merchandise or display is deemed by SPC officials to be not in keeping with the spirit of the event, offensive or morally objectionable.
- 7. Agree to provide access to the exhibit to an authorized SPC official at all times.
- 8. Agree that no pets be allowed on the premises other than seeing-eye dogs.
- 9. Agree no alcoholic beverages are to be brought on premises, whether for sale or personal use.
- 10. Agree in all matters of dispute not covered in this agreement, that the decisions of the SPC are final.
- 11. Electricity will be provided only for necessary functions of the vendor.

Vendor has read and understands all the terms of this agreement and agrees to abide by such.
